Prevent the spread of PED & PDCOV

Producers and each partner along the supply chain should maintain vigilant biosecurity measures and evaluate their exposure risks to the farms and off-site livestock assembly yards that they visit.

Preventing PED/PDCOV



Transporters

- **Pigs need a clean ride:** Genetic stock is the highest priority, weanling and feeder pigs are the next highest priority.
- **Dirty places are DIRTY places:** Cull assembly yards are the highest risk to any trailer. All processing plants are also high risk.
- Know what pigs were on your trailer: If you
 have been hauling shedding pigs, these trailers
 are covered with infectious virus. These trailers
 must have a very detailed wash, disinfect and dry.
- Transportation also includes the tractor: Detailing the power unit is very important.
- Wash your wash bay: Reduce contamination of your wash bay by scraping known positive trailers offsite at a designated spot, then soaking the trailer prior to washing with a disinfectant such as Synergize or Prevail.
- Always follow your biosecurity procedures:
 Always use your dedicated footwear/coveralls or PPEs according to our business' procedures.

Protect yourself from being the one to spread disease!

Producers

- Conduct rule-out testing and consult your veterinarian when noticing any symptoms
- If a barn tests positive, ensure all partners are notified as soon as possible
- Limit access on your farm
- Have dedicated clothing/footwear/equipment inside the barn
- Disinfect items that have to move between barns
- Shower in and out/Danish entry/chute extension
- Lime your loading docks/entries
- Ensure all trailers are cleaned and disinfected
- Make sure that the barn and yards allow drivers to effectively change boots/coveralls/PPEs
- Take care around manure spreading near other hog barns and cleaning of shared equipment
- Control rodents, birds and other wildlife
- If your deadstock is picked up, don't cross traffic with deadstock trailers

Everything outside of the barn door (including your yard) should be considered contaminated!





Industry Partners

- Limit farm visits to essential needs only
- Move from high health/biosecurity sites to lower health/biosecurity sites within the day/week
- Use dedicated clothing and footwear provided by the producer OR bag all used clothing for wash as soon as possible and do not wear the same clothes on multiple sites
- Disinfect footwear thoroughly between sites, using boot covers upon exiting your vehicle
- Leave any disposable items at the farm for disposal; if not possible, ensure garbage is bagged and contained for disposal offsite
- Shower in and out and respect Danish entries
- Ensure all vehicles are cleaned and disinfected inside and out frequently
- Store clean supplies in your vehicle separately from dirty supplies for cleaning
- Keep disinfecting wipes and a sanitizing spray (e.g., Prevail) on hand at all times
- If you notice any potential symptoms in the barn, notify the producer

Assume every site you visit might be contaminated!
